This frame structure was connected with another building but the firement cut off the path of the flames, which was very good work. The Elizabethtown Fire Company also responded but did not go into service.

The entire building 24x36 feet and its contents which included 312 new tires, 550 tubes, and all kinds of other auto accessories, were burred. The loss is estimated at \$12,000 partly covered by insurance.
